



## INSIGHTCM™ END USER LICENSE AGREEMENT

CAREFULLY READ THIS SOFTWARE LICENSE AGREEMENT ("AGREEMENT"). BY DOWNLOADING THE SOFTWARE AND/OR CLICKING THE APPLICABLE BUTTON TO COMPLETE THE INSTALLATION PROCESS, YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT WISH TO BECOME A PARTY TO THIS AGREEMENT AND BE BOUND BY ITS TERMS AND CONDITIONS, DO NOT INSTALL OR USE THE SOFTWARE; RETURN THE SOFTWARE (WITH ALL ACCOMPANYING WRITTEN MATERIALS AND THEIR CONTAINERS) WITHIN THIRTY (30) DAYS OF RECEIPT. ALL RETURNS TO CUTSFORTH WILL BE SUBJECT TO CUTSFORTH'S THEN-CURRENT RETURN POLICY. IF YOU ARE ACCEPTING THESE TERMS ON BEHALF OF AN ENTITY, YOU ACKNOWLEDGE THAT YOU HAVE AUTHORITY TO BIND THE ENTITY TO THESE TERMS.

1. The terms of this Agreement apply to the computer software and other code provided with this Agreement, all updates or upgrades to the software that may be provided later by CUTSFORTH as part of any maintenance, technical support, or other services program for the software, unless such update or upgrade comes with separate software license terms, and all accompanying documentation and utilities (collectively "Software" or "SOFTWARE"). Software does not include certain third-party software that CUTSFORTH provides to you but that is subject to separate license terms either presented at the time of installation or otherwise provided with the Software ("Third Party Software"). Notwithstanding anything to the contrary contained herein regarding certain Third-Party software, the SOFTWARE provided includes certain software code from National Instruments and others which will be subject to the terms of this agreement.
2. Grant of License; Restrictions
  - A. In consideration of and conditioned upon your payment of any applicable fees to CUTSFORTH and subject to the terms set forth in this Agreement, Cutsforth, as applicable depending on the country of manufacture, hereby grants you a limited, revocable, non-exclusive right and license to use the Software only in the specific configuration allowed by the license type identified in the applicable documentation provided by CUTSFORTH to you. Unless otherwise provided in this Agreement or in the applicable documentation provided by CUTSFORTH to you, the applicable license type is a named user license and the term of the license, if purchased and not evaluation, is perpetual and not term. Software is for your internal use only.
  - B. Restrictions. You must not:
    - (i) modify or create derivatives of the Software;
    - (ii) install or use the Software in a floating, concurrent, or any other shared context (not including access to the Software from a web browser);
    - (iii) distribute or otherwise make the Software or any password, key, or other access code for the Software available to any third party;
    - (iv) reverse engineer, decompile, or disassemble the Software, unless and only to the extent that applicable law expressly prohibits this restriction;
    - (v) defeat or work around any access restrictions or encryption in the Software, unless and only to the extent that applicable law expressly prohibits this restriction;
    - (vi) sublicense, lease, lend, or rent the Software; or
    - (vii) remove, minimize, block, or modify any titles, logos, trademarks, copyright and patent notices, digital watermarks, disclaimers, or other legal notices that are included in the Software, whether or not they belong to CUTSFORTH or a third party.
  - C. Your use of the Software must also be in accordance with the applicable documentation that accompanies the Software and not in any manner that circumvents or is intended to circumvent such documentation or the intent of this Agreement.
  - D. You may make a reasonable number of copies of the Software solely for backup or archival purposes and a reasonable number of copies of the documentation that accompanies the Software solely for your internal use in connection with your use of the Software. Safeguarding the Software. The Customer shall apply the following basic safeguarding



requirements and procedures to protect its utilization of the Software. Requirements and procedures for basic safeguarding of the Software shall include, at a minimum, the following security controls:

- (i) Limit information system access to authorized users, processes acting on behalf of authorized users, or devices (including other information systems).
- (ii) Limit information system access to the types of transactions and functions that authorized users are permitted to execute.
- (iii) Verify and control/limit connections to and use of external information systems.
- (iv) Control information posted or processed on information systems.
- (v) Identify information system users, processes acting on behalf of users, or devices.
- (vi) Authenticate (or verify) the identities of those users, processes, or devices, as a prerequisite to allowing access to organizational information systems.
- (vii) Sanitize or destroy information system media containing information before disposal or release for reuse.
- (viii) Limit physical access to organizational information systems, equipment, and the respective operating environments to authorized individuals.
- (ix) Escort visitors and monitor visitor activity; maintain audit logs of physical access; and control and manage physical access devices.
- (x) Monitor, control, and protect organizational communications (i.e., information transmitted or received by organizational information systems) at the external boundaries and key internal boundaries of the information systems.
- (xi) Implement subnetworks for publicly accessible system components that are physically or logically separated from other internal networks.
- (xii) Identify, report, and correct information and information system flaws in a timely manner.
- (xiii) Provide protection from malicious code at appropriate locations within organizational information systems.
- (xiv) Update malicious code protection mechanisms when new releases are available.
- (xv) Perform periodic scans of the information system and real-time scans of files from external sources as files are downloaded, opened, or executed.

### 3. License Types

- A. **Production License.** The SOFTWARE may only be installed and used on one (1) physical or virtual computing device (each a "computer") used to monitor no more than the number of nodes specified in the license documentation (e.g., invoice, serial number card). For the purposes of this license, multiple physical computing devices each hosting a portion of the SOFTWARE but which such computing devices act together as one (1) system shall be considered an individual computer. For the purposes of this license, multiple systems interacting with the computing device on which the SOFTWARE is run and pulling information from the computing device shall not be considered running the SOFTWARE on a separate computing device.

You must have a hardware access license for each monitoring and acquisition device that is connected to the SOFTWARE. Each user connected to the computer for viewing data or configuring the SOFTWARE must have an InsightCM User License. Neither hardware access licenses nor InsightCM User Licenses are included with this SOFTWARE license.

- B. **Development License.** If you have a copy of the SOFTWARE for development purposes, including but not limited to SOFTWARE identified as a development version and any copy of SOFTWARE that you have received with a copy of



InsightCM SDK, then you may use one (1) copy of the SOFTWARE internally solely for the purpose of testing any program that you have developed with the InsightCM SDK and for no other purpose. SOFTWARE subject to a development license may not be used in production.

4. Additional Terms. You may have additional rights and obligations to the Software through special license types and license programs, as set forth in addenda to this Agreement and which are incorporated as part of this Agreement. In the event of a conflict between an addendum and the other terms set forth in this Agreement, the terms of the addendum will control.

Addendum A Evaluation License; Pre-Release Software Terms

5. Third Party Contractors. Your third-party contractors may access and use the Software, provided that they do so solely for your benefit, they agree to use the Software solely in accordance with the terms of this Agreement, and you agree to remain liable to CUTSFORTH for any breach by your contractors of this Agreement.
6. Software Services. This Agreement does not entitle you to any upgrades or maintenance, technical, or other services for the Software ("Software Services"), which you may be required to purchase separately.
7. License Term; Termination and Expiration
- A. Term Licenses. If you have purchased a term license, the term of the license will commence on the date of your order and, unless terminated pursuant to the provisions herein, continues for the period of time specified in the product description or other applicable documentation provided to you by CUTSFORTH. The license will expire automatically at the end of such term.
- B. Perpetual Licenses. If you have purchased a license and the license is specified as "perpetual" or no period of time is specified in the product description or other applicable documentation provided to you by CUTSFORTH, your license will be perpetual and, unless terminated pursuant to the provisions herein, you have the right to use the Software indefinitely.
- C. Termination. CUTSFORTH conditions its license grant on you complying with the terms set forth in this Agreement, and this Agreement will automatically terminate, immediately and without prior notice, if you fail to comply with its terms.
- D. Effect of Termination or Expiration. Upon termination or expiration of this Agreement, regardless of the reason, the license grants contained herein will terminate and you must immediately cease all use of the Software and destroy all copies of the Software; provided, however, you must deliver the Software and all copies to CUTSFORTH if CUTSFORTH has so demanded in lieu of any destruction. Sections 11, 14, 15, 16, 18, 19, 20, 21.A, and 22 of this Agreement will survive any expiration or termination of this Agreement.
- E. Change of Terms. Cutsforth reserves the right to modify this Agreement at its discretion and will mark new versions with a corresponding effective date. Customer's continued use of the Software constitutes their agreement to Cutsforth's then-current Agreement. Cutsforth also reserves the right to discontinue hardware or software products or versions and accordingly stop supporting products or versions one (1) year after discontinuance, or otherwise discontinue any Support Service at any time. This Agreement sets forth Customer's sole remedies for any claim relating to the amendment or discontinuance of the Software, including any failure to provide the Integration Software or Support Services hereunder. These Terms may only be modified as set forth herein and any different or additional terms of any related purchase order, confirmation, or similar form, even if signed by the parties after the Effective Date hereof, shall have no force or effect.
8. Transfer. You may transfer a license to a third party in the same country in which you purchased the license, or within the European Union if you purchased the license in the European Union, provided that (i) you notify CUTSFORTH in writing of such transfer, including the name and location of such third party; (ii) such third party accepts the terms and conditions of this Agreement; and (iii) after such transfer you do not retain any copies of the Software or any of the written materials accompanying the Software. CUTSFORTH may, in its discretion, charge you a fee for the license transfer.
9. Upgrades; Prior Versions. If the Software is an upgrade, you may only use the Software if you have a valid license to use the prior version of the Software, and you may not use both the upgrade and the prior version of the Software concurrently. You may elect to use a prior version of any Software delivered and licensed under this Agreement in lieu of using the Software delivered and licensed under this Agreement ("Delivered Software"), provided (i) you have an authorized copy of the prior version of the Delivered Software; (ii) all use is pursuant to and in accordance with this Agreement; and (iii) notwithstanding anything in this Agreement to the contrary, in no event will CUTSFORTH be required to support any version



of the Software, including providing applicable software key codes or hardware keys, other than the then most current version of the Delivered Software.

10. Multiple Versions. If CUTSFORTH distributes the Software on installation media containing multiple versions of the Software for use with different operating systems, you may use only one version of the Software.
11. Software/Hardware Key; Prior Access. You agree to use any software key codes or hardware keys provided by CUTSFORTH solely with the Software for which it is provided. While CUTSFORTH may in its sole discretion provide you with the applicable key or other access to use the Software prior to receipt from you of the applicable license fees, you will remain obligated to pay such fees to CUTSFORTH.
12. Copyright; No Other Licenses. The Software is licensed and not sold. The Software, all copies of the Software, related contents, and all rights therein, are owned by CUTSFORTH or its suppliers and are protected by applicable copyright laws and international treaty provisions. All rights not expressly granted to you in this Agreement are reserved to CUTSFORTH. Further, and without limiting the foregoing, no license or any right of any kind, whether by express license, implied license, the doctrine of exhaustion, or otherwise, is granted under any CUTSFORTH patents (whether identified herein or not) or other intellectual property right of CUTSFORTH with respect to any other product of CUTSFORTH or of any third party, including the right to use any such other product.
13. Limited Warranty. CUTSFORTH warrants, for your benefit alone, that for a period of ninety (90) days from the date the Software is shipped to you or, if downloaded, from the date the Software is first downloaded by you, (i) the Software will perform substantially in accordance with the documentation that accompanies the Software and (ii) the installation media on which CUTSFORTH provides the Software (if any) will be free from defects in materials and workmanship under normal use and service ("Limited Warranty"). Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. Some jurisdictions do not allow exclusion of or limitation on duration of an express or implied warranty or limitation on any applicable statutory rights of a consumer, so the above limitations may not apply to you; in such event, such warranties are limited to the minimum warranty period allowed by applicable law. The Limited Warranty is void if failure of the Software has resulted from accident, abuse, misapplication, improper calibration by you, third party products (either hardware or software) used by you that are not intended by CUTSFORTH for use with the Software, utilization of an improper hardware or software key, or unauthorized maintenance of the Software.
14. Customer Remedies. CUTSFORTH's sole obligation, and your sole remedy, with respect to the foregoing Limited Warranty will be to, at CUTSFORTH's option, repair or replace the Software or return the fees paid by you to CUTSFORTH for the Software license, in which event you must return or destroy all copies of the Software in accordance with CUTSFORTH's instructions and the license granted to you will terminate without liability on the part of CUTSFORTH by reason of such termination. CUTSFORTH's obligations as set forth in this Section are contingent on you providing CUTSFORTH with written notice of applicable defects during the warranty period. In addition, you must obtain a Return Material Authorization number from CUTSFORTH before returning the Software under warranty to CUTSFORTH, and you agree to pay any expenses for shipment to and from CUTSFORTH.
15. No Other Warranties. **EXCEPT AS EXPRESSLY SET FORTH IN THIS AGREEMENT, NO WARRANTY, EITHER EXPRESS OR IMPLIED, IS MADE BY CUTSFORTH WITH RESPECT TO THE SOFTWARE OR USE OF THE SOFTWARE. CUTSFORTH DOES NOT MAKE ANY WARRANTY OR REPRESENTATION HEREUNDER WITH RESPECT TO ANY THIRD-PARTY SOFTWARE, SOURCE CODE, OR SOFTWARE SERVICES. CUTSFORTH DOES NOT WARRANT, GUARANTEE, OR MAKE ANY REPRESENTATION THAT THE SOFTWARE, THE OPERATION OF THE SOFTWARE, OR ANY RELATED SOFTWARE SERVICES, SOURCE CODE, OR THIRD-PARTY SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE AND DOES NOT WARRANTY, GUARANTEE, OR MAKE ANY REPRESENTATION REGARDING CORRECTNESS, ACCURACY, RELIABILITY, OR OTHERWISE. THERE ARE NO OTHER WARRANTIES THAT MAY ARISE FROM USAGE OF TRADE OR COURSE OF DEALING. CUTSFORTH DISCLAIMS ANY AND ALL IMPLIED WARRANTIES, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON- INFRINGEMENT, RELATING TO THE SOFTWARE AND ANY RELATED THIRD-PARTY SOFTWARE, SOURCE CODE, AND SOFTWARE SERVICES.**
16. Limitations Period. You hereby agree not to bring an action to enforce your remedies under the Limited Warranty or for breach of warranty more than one (1) year after the accrual of such cause of action.
17. Intellectual Property Liability. CUTSFORTH will, at its own expense, defend any claim brought against you by a third party resulting from your use of the Software, to the extent that such claim alleges that the Software infringes any patent, copyright, or trademark of such third party protected by the laws of the U.S.A., Canada, Mexico, Japan, Australia, Switzerland, Norway, or the European Union and provided that such claim does not arise from (i) your use of the Software in combination with



equipment, devices, software, or code not made by CUTSFORTH; (ii) your use of the Software in a manner not in accordance with this Agreement or for a purpose not intended by CUTSFORTH; (iii) your failure to incorporate Software updates or upgrades provided by CUTSFORTH that would have avoided the alleged infringement; or (iv) any modification of the Software not made by CUTSFORTH. CUTSFORTH'S obligations in this Section are further contingent on you notifying CUTSFORTH in writing promptly upon your obtaining notice of such impending claim and you fully cooperating with CUTSFORTH in preparing a defense. If you provide to CUTSFORTH the authority, assistance, and information CUTSFORTH needs to defend or settle such claim, CUTSFORTH will pay any final award of damages or settlement with respect to such claim and any expense you incur at CUTSFORTH's written request. CUTSFORTH will not be liable for a settlement made without its prior written consent. If the Software is held to be infringing of the rights stated above in this Section and the use of the Software is enjoined, CUTSFORTH will, or if CUTSFORTH believes the Software might be held to infringe a third party's intellectual property rights CUTSFORTH may, at its option, (i) procure for you the right to use the Software; (ii) replace or modify the Software with other software that does not infringe; or (iii) receive your return of the infringing Software and refund to you the license fee payment made by you to CUTSFORTH for the Software. **TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, CUTSFORTH'S LIABILITY, THE LIABILITY OF ITS LICENSORS AND SUPPLIERS, AND THE LIABILITY OF ITS AND THEIR DIRECTORS, OFFICERS, EMPLOYEES, AND AGENTS, UNDER THIS SECTION AND REGARDLESS OF THE REASON FOR SUCH LIABILITY, WILL NOT EXCEED IN THE AGGREGATE \$50,000 (U.S.) OR THE PURCHASE PRICE OF THE SOFTWARE, WHICHEVER IS GREATER.** The foregoing states your sole remedy for, and CUTSFORTH's entire liability and responsibility for, infringement of any patent, trademark, copyright, or other intellectual or industrial property right relating to the Software. **THIS LIMITED INDEMNITY IS IN LIEU OF ANY OTHER STATUTORY OR IMPLIED WARRANTY AGAINST INFRINGEMENT. THE FOREGOING OBLIGATIONS WILL NOT APPLY TO ANY THIRD-PARTY SOFTWARE OR TO ANY THIRD PARTY PRODUCTS INCORPORATED IN OR OTHERWISE PROVIDED WITH THE SOFTWARE, AND YOU AGREE TO LOOK TO THE APPLICABLE THIRD PARTY MANUFACTURER WITH RESPECT TO ANY CLAIMS FOR INFRINGEMENT INVOLVING THIRD PARTY SOFTWARE OR THIRD PARTY PRODUCTS.**

18. **Indemnification.** You shall defend, indemnify, and hold harmless Cutsforth and its licensors from any and all claims, suits, demands, actions, governmental sanctions, damages, and costs (including reasonable attorneys' fees) arising out of or resulting from: (i) the use of the Software or (ii) end-user's breach of its binding agreement
19. **LIMITATION ON LIABILITY.** **TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL CUTSFORTH OR ITS LICENSORS, DISTRIBUTORS, OR SUPPLIERS (INCLUDING CUTSFORTH'S AND THEIR DIRECTORS, OFFICERS, EMPLOYEES, AND AGENTS) BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, PUNITIVE, EXEMPLARY, OR CONSEQUENTIAL DAMAGES OF ANY KIND, INCLUDING DAMAGES ARISING FROM LOST PROFITS, LOST SAVINGS, LOST BUSINESS OPPORTUNITY, BUSINESS INTERRUPTION, OR LOST OR CORRUPTED DATA OR SOFTWARE, EVEN IF CUTSFORTH OR ITS LICENSORS, DISTRIBUTORS, OR SUPPLIERS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND REGARDLESS OF WHETHER CAUSED OR CONTRIBUTED TO BY THE NEGLIGENCE OF CUTSFORTH OR OTHERS, AND, EXCEPT AS SET FORTH IN SECTION 17, IN NO EVENT WILL CUTSFORTH'S LIABILITIES UNDER THIS AGREEMENT, WHETHER UNDER CONTRACT LAW, TORT LAW, WARRANTY, OR OTHERWISE, EXCEED THE TOTAL AMOUNT RECEIVED BY CUTSFORTH FOR THE APPLICABLE SOFTWARE LICENSE.**

You acknowledge that the applicable fees and prices reflect this allocation of risk. To the extent the foregoing limitation of liability is not enforceable or fails of its essential purpose, except for liability for bodily injury or death caused by the Software in the form provided by CUTSFORTH or any liability not capable of being excluded by applicable law, the sole liability of CUTSFORTH to you under or in connection with this Agreement shall be limited to the greater of \$50,000 (U.S.) or the license fee paid to CUTSFORTH for the Software.

## 20. **HIGH-RISK USES AND YOUR RESPONSIBILITIES**

**B. YOU ACKNOWLEDGE AND AGREE THAT YOU ARE RESPONSIBLE FOR TAKING STEPS TO PROTECT AGAINST PRODUCT AND SYSTEM FAILURES, INCLUDING PROVIDING BACK-UP OR SHUTDOWN MECHANISMS. BECAUSE EACH END-USER SYSTEM IS CUSTOMIZED AND DIFFERS FROM CUTSFORTH'S TESTING PLATFORMS AND BECAUSE YOU MAY USE CUTSFORTH PRODUCTS IN COMBINATION WITH OTHER PRODUCTS IN A MANNER NOT EVALUATED OR CONTEMPLATED BY CUTSFORTH, YOU ARE ULTIMATELY RESPONSIBLE FOR VERIFYING AND VALIDATING THE SUITABILITY OF CUTSFORTH PRODUCTS FOR YOUR INTENDED USE. YOU WILL DEFEND, INDEMNIFY, AND HOLD HARMLESS CUTSFORTH AND ITS DIRECTORS, OFFICERS, EMPLOYEES, AND AGENTS FROM ANY AND ALL CLAIMS, LOSSES, DAMAGES, ACTIONS, AND EXPENSES (INCLUDING REASONABLE ATTORNEYS' FEES) ARISING OUT OF YOUR INCORPORATION OF THE SOFTWARE IN YOUR SYSTEM OR APPLICATION; PROVIDED, HOWEVER, THAT YOUR CONTRACTUAL OBLIGATION OF INDEMNIFICATION SHALL NOT EXTEND TO THE PERCENTAGE OF THE CLAIMANT'S DAMAGES OR INJURIES OR THE SETTLEMENT AMOUNT ATTRIBUTABLE TO CUTSFORTH'S NEGLIGENCE OR OTHER FAULT OR TO STRICT LIABILITY IMPOSED UPON CUTSFORTH AS A MATTER OF LAW.**

21. U.S. Government Rights. The Software is a "commercial item" developed exclusively at private expense, consisting of "commercial computer software" and "commercial computer software documentation" as such terms are defined or used in the applicable U.S. acquisition regulations. If you are an agency, department, or other entity of the United States Government, the Software is licensed hereunder (i) only as a commercial item and (ii) with only those rights as are granted to all other licensees pursuant to the terms and conditions of this Agreement. You agree not to use, duplicate, or disclose the Software in any way not expressly permitted by this Agreement. Nothing in this Agreement requires CUTSFORTH to produce or furnish technical data for or to you.

22. Compliance

A. You agree to make, upon reasonable notice, all applicable records available for review by CUTSFORTH during normal business hours so as to permit CUTSFORTH to verify your compliance with the terms and conditions of this Agreement. CUTSFORTH may, upon written notice, inspect your use of the Software during normal business hours to ensure your compliance with this Agreement. Further, if you are a business or other entity, you agree that upon the request of CUTSFORTH or its authorized representative you will promptly document and certify in writing to CUTSFORTH that you and your employees' use of the Software complies with the terms and conditions of this Agreement. 23. General

A. Governing Law; Venue. This Agreement is governed by the laws of the State of New York, U.S.A., exclusive of any provisions of the United Nations Convention on the International Sale of Goods, and without regard to principles of conflicts of law. The non-exclusive venue for all actions under this Agreement will be in the courts located in Minneapolis, MN, U.S.A., and the parties agree to submit to the jurisdiction of such courts.

B. This Agreement constitutes the complete agreement between you and CUTSFORTH regarding use of the Software and supersedes any oral or written proposals, prior agreements, purchase orders, or any other communication between you and CUTSFORTH relating to the subject matter of this Agreement. CUTSFORTH's applicable standard Terms and Conditions of Sale, the current version of which is set forth at , will apply to any technical support services provided as part of Software Services and to any Training & Certification Services; provided, however, as set forth herein the provisions of this Agreement may apply and control with respect to any upgrades or updates or other Software that may be provided as part of or in connection with any such services. No delay or omission by CUTSFORTH to exercise any right or power it has under this Agreement will impair or be construed as a waiver of such right or power. Any waiver



by CUTSFORTH of a term of this Agreement must be in writing by CUTSFORTH. The waiver by CUTSFORTH of any breach of any provision hereof will not be construed to be a waiver of any succeeding breach of that provision or of any breach of any other provision. No modification of this Agreement will be effective unless set forth in a writing signed by a duly authorized representative of you and CUTSFORTH. The word "including" as used in this Agreement will be understood as meaning "including without limitation". If you are unable to access the internet to view any of the web pages referred to in this Agreement, you may request the information from your CUTSFORTH sales representative.

- C. If any action is brought by either party to this Agreement against the other regarding the subject matter hereof, the prevailing party will be entitled to recover, in addition to any relief granted, reasonable attorney's fees and court costs.
- D. If any provision of this Agreement is held invalid, the offending clause will be modified so as to make it enforceable, as modified, and the remainder of this Agreement will continue in full force and effect.
- E. Software is, and Third-Party Software and Source Code may be, subject to control under the U.S. Export Administration Regulations (15 CFR Part 730 et. seq.), other applicable U.S. export control laws and regulations, and applicable global export control laws and regulations, including, for products exported from the European Union, the Council Regulation (EC) No. 428/2009. You represent and warrant that you are not ineligible or otherwise restricted by US or applicable law to receive any copies of the Software, Third Party Software, or Source Code. CUTSFORTH reserves the right not to ship or permit downloading of the Software ordered if, at any time, CUTSFORTH believes that such shipment or downloading of such Software, Third Party Software, or Source Code may violate U.S. or other applicable export control laws. You agree that you will not export, re-export, or transfer any Software, Third Party Software, or Source Code in violation of any U.S. and applicable global export control laws and that you will not export, re-export, or transfer the Software, Third Party Software, or Source Code by any means to (i) any person or entity on OFAC's List of Specially Designated Nationals or on BIS's Denied Persons List, Entity List, or Unverified List, or any other applicable restricted party list or (ii) any prohibited destination, entity, or individual without the required export licenses or authorizations from the U.S. Government or other applicable export licensing authority.

THE SOFTWARE MAY CONTAIN CODE THAT WILL, AFTER A CERTAIN TIME PERIOD, DEACTIVATE THE SOFTWARE AND RENDER THE SOFTWARE UNUSABLE, AND IT MAY DO SO WITHOUT WARNING.**

Upon such deactivation, this Agreement will be considered terminated. CUTSFORTH may in its sole discretion terminate the evaluation license at any time.
